7. The Bidders has to submit (Upload Scan Copies/fill) his offer/credentials online as required in the tender in the online templates in relevant envelopes.

EMD, Live Registration copy, GST/ or GST Clearance, Bank Solvency (Minimum 15% of Pac amount) and Affidavit on Non Judicial Stamp worth Rs.100/- should be essentially submitted by the Tender along with Other necessary documents by Registered / Speed Post only to Executive Engineer, Room No. 413, Superintending Engineer Office (PWD), Nagar Nigam Raipur, Mahatma Gandhi Sadan, New Building , Raipur, near Mahila Police Station. It is essentially to submit Affidavit worth Rs. 100/- and EMD physical by speed post or Registered post only.
11. The bidder should have qualified technical supervisory staff and other operational staff in their role. (Attach a list of such staff with their C.V's along with all supporting documents)
12. The bidder should have minimum site testing equipments for execution of job.
13. The bidder should have to submit the experience certificate duly certified by Executive Engineer or equivalent officer for the similar Nature of work.
